
Introduction







Year to Date Comparison of Violations for FY 2019 and FY 2018









Year to Date Comparison of Licenses Sold for FY 2019 and FY 2018



5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (www.asilomaraccords.org) which were generated by animal welfare professionals as a way for agencies to accurately report a "Live Release Rate," or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all "healthy" and "treatable" animals as well as many "unhealthy" animals. SVACA's Animal Care Center is "no kill" as we annually save greater than 90% of the animals received.

- The following are a sampling of adoption cases that highlight the good work that staff does in an effort to find lifelong homes for all of our animal guests.
 - o Cadence was found in an industrial area where there are mostly feral cats, but she was quite friendly. Due to her senior age and where she was found, it was very possible she was abandoned. With the weather staying warm late this year, we already had most of our adoption rooms filled with young kittens. It can be challenging to find a home for a senior cat especially during kitten season. One of SVACA's medical volunteers and foster moms who had met Cadence couldn't stop thinking about her. She returned from an overseas trip and was delighted to see that Cadence was still available and adopted her right away! The staff gets to hear regular updates about Miss Cadence, now known as Pumpkin and judging by the photos she looks extremely happy and content in her forever home!

MEDICAL TEAM

- The following are a sampling of the good work that our medical team does day-in and out as we attempt to make sick and injured animals healthy so they can be adopted, released to a placement partner, or returned to their owner.
 - o Mars and his brother Chance arrived with a severe upper respiratory infection which not only caused nasal and ocular discharge but resulted in ulcerations on their eyes. As they cleared the infection, they were assessed at Animal Eye Specialists where Dr. Burling gave us the great news that Mars' eyes were visual and healing well though he would likely always have some scarring. Her news for Chance was not as uplifting as his left eye needed to be removed. One of our veterinarians removed it and after about a week of healing both Chance and Mars went into our adoption gallery.
