
Introduction

This report provides graphs, tables and explanatory narratives covering five categories of information: field service calls, violations and citations issued, animals impounded, animals licensed, and animal outcomes. SVACA's fiscal year is July 1 – June 30.

1. Field Service Calls







Year to Date Comparison of Violations for FY 2018-19 and FY 2017-18






3. Animals Received at Center



Year to Date Comparison of Licenses Sold for FY 2018-19 and FY 2017-18



5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (www.asilomaraccords.org) which were generated by animal welfare professionals as a way for agencies to accurately report a "Live Release Rate," or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all "healthy" and "treatable" animals as well as many "unhealthy" animals. SVACA's Animal Care Center is "no kill" as we annually save greater than 90% of animals received.



It was love at first purr and the couple was overjoyed to bring the boys home just after the holidays!

December saw the last of our foster animals make their way into the adoption gallery and seek forever families. We were surprised to have a handful of 2-3 month old kittens become available during our Home for the Holidays adoption event. The last puppy of 2018 was Luna, an approximately 3 month old mixed terrier, who returned for adoption at the end of the year and is meeting many families in search of her perfect match. The end of 2018 saw a growth spurt in our medical department. Working with our Outreach Coordinator and the Friends of SVACA, we were able to secure new equipment to enhance the quality of care for our patients! The Friends of SVACA covered the cost of an incubator for our Center and will have mulltiple uses; its inaugural us was housing a juvenille ball python found near a dumspter in a Santa Clara apartment complex. In the spring, we will use it to house baby critters of all kinds. The incubator allows us to house animals that cannot

regulate their own body temperature. It will serve as temporary housing for wildlife and very young kittens.



Home, warm, Home!

Thanks to SVACA's Board of Directors and Animal Assistance Fund donors, we purchased Abaxis laboratory equipment. With two new machines we will be able to run in-house bloodwork, allowing us to make decisions on care more quickly than if we sent out samples to a reference laboratory. The new blood analyzers will not replace the use of reference laboratories completely but will give us more insight into our patients and their specific needs. The purchase also came with a new microscope; the scope has a camera and large viewing screen. The camera will allow us to save images, for reference of education and the larger viewing screen allows multiple members of the team to see the same image.




Takin' a look, deep inside!

The last, but certainly not least, enhancement to our department is the acquisition of our digital radiography machine. We have been working with local agencies and clinics for out imaging but this purchase will allow us to obtain these images rapidly and be able to repeat radiographs over time without incurring additional cost. Having the ability to take radiographs onsite also means less movement for our injured patients. The images are of excellent quality and can be easily exported to our veterinarians for review.

These changes are exciting and come with educational opportunities not only for the medical personnel but all of our staff. We are grateful to all the people involved in the research and purchasing process to keep SVACA moving forward in the animal sheltering and care industry.

FIELD SERVICES TEAM

 After the devastating wildfire in Butte County, SVACA's own Officer Tucker responded to assist state and local agencies with animal related tasks. She worked shoulder to shoulder with other officers, shelter staff and veterinarians from all over the state.
