DISCUSSION

Staff is proud to report that in 2018 SVACA saved 95% of our animals. 97% of dogs, 94% of cats and 100% of other (rabbits, birds, hamsters, etc.) animals were saved. Staff and volunteers have worked diligently over the years to save more lives every year through the development and implementation of programs like Happy Meower, Feral Freedom and Project Reunite. The following table lists SVACA's ever improving live release rate since 2010.
