
Introduction

This report provides graphs, tables and explanatory narratives covering five categories of information: field service calls, violations and citations issued, animals impounded, animals licensed, and animal outcomes. SVACA's fiscal year is July 1 – June 30.

1. Field Service Calls



Graph 2a. - Total Service Calls by Jurisdiction, Type and Sub-Type for November 2021





Year to Date Comparison of Violations for FY 2021-22 and FY 2020-21









Year to Date Comparison of Licenses Sold for FY 2021-22 and FY 2020-21



5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (www.asilomaraccords.org) which were generated by animal welfare professionals as a way for agencies to accurately report a "Live Release Rate," or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all "healthy" and "treatable" animals as well as many "unhealthy" animals. SVACA's Animal Care Center is "no kill" as we annually save greater than 90% of animals received.

Giving Tuesday push on social media and through an electronic letter brought results!


Volunteers

Though he was already 11 years old, the first person he met for a potential adoption just couldn't leave without taking him home. The adopter and her small dog immediately bonded with Linc. MEDICAL TEAM

- The following are a sampling of the good work that our medical team does day-in and out as we attempt to make sick and injured animals healthy so they can be adopted, released to a placement partner, or returned to their owner.
 - A Boston Terrier mix was reported in Mountain View after following a citizen on her bike. Animal Control Officer Morris went to the area to find the pooch running in and out of traffic, bringing this little girl back to the Center. Officer Morris could see a large wound that was superficial and healing. There was also a bluish/purple "ink" on her coat around the wound. Our medical team applied a topical cleansing and antibiotic spray to the injury. The colorful décor was likely an over-the-counter antiseptic spray often used in large animal medicine. Our medical team named her Violet for the lovely shade of purple on her coat. She was adopted quickly, the day she moved into the adoption gallery, and renamed Minnie by her new family.

o In late November, a senior orange tabby DSH, was captured in a humane trap at a nearby Santa Clara industrial area. Our medical team treated a wound at the tail base that was not actively bleeding. The wound was suspected to be an abscess that had ruptured; not an uncommon occurrence for intact community cats. The medical team treated the wound and after several weeks of ongoing care, he was healed enough to return to his colony vaccinated, microchipped and neutered.

A local trapper assisted a Santa Clara resident who had seen several cats in the neighborhood which led to Kenny arriving at SVACA's Animal Care Center with his sister Dolly. Dolly had a mild upper respiratory infection and Kenny had a gastrointestinal infection. They were started on antibiotics and sent to foster care for TLC. About 2 weeks later they were well past their illnesses and on their way to being cuddly kittens. Both were adopted for the new year!

FIELD SERVICES TEAM

• In Santa Clara, Officer Morris responded to a call from the police department requesting her assistance regarding a dog in distress inside of a vehicle. Upon arrival, Officer Morris observed a Shih Tzu whose limbs and mouth were bound with duct tape which prevent him from barking and escaping the vehicle. The dog was immediately seized and the tape was removed. The owner was arrested and charged with violating Penal Code 597 "Crimes against Animals," and is currently awaiting trial. Amazingly, this canine did not let this experience phase him in the least and his happy-go-lucky personality got him adopted into his fur-ever home right away! His new name is Prince Harry.

 In Campbell, Officer Morris responded to 2 skunks stuck in a storm drain in the middle of a grassy area at Campbell Park. The grate was stuck, and human power was not enough to remove it. City workers were nearby and had access to a backhoe which they used to remove the grate. The skunks were carefully and quietly removed from the drain and released into brush along the Los Gatos Creek Trail.
