
Introduction



Graph 2a. - Total Service Calls by Jurisdiction, Type and Sub-Type for May 2022





Year to Date Comparison of Violations for FY 2021-22 and FY 2020-21






3. Animals Received at Center



Year to Date Comparison of Licenses Sold for FY 2021-22 and FY 2020-21



5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (www.asilomaraccords.org) which were generated by animal welfare professionals as a way for agencies to accurately report a "Live Release Rate," or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all "healthy" and "treatable" animals as well as many "unhealthy" animals. SVACA's Animal Care Center is "no kill" as we annually save greater than 90% of animals received.

 We continue to hold planning meetings and donations are coming in. We've hired a caterer and applied for the appropriate special permits. Tickets will go on sale August





Volunteers

- We held a volunteer orientation in May and onboarded twenty-seven recruits.
- We held two dog mentoring classes to train new volunteers in May and June.
- Staff held a foster orientation in June and recruited several new foster families.

Marketing

 We ran a Slam Dunk adoption special in honor of Steph Curry's NBA Finals MVP award and offered an adoption fee of \$30 for select animals for Curry's jersey number 30.



The It's a SLAM DUNK special offered reduced adoption fees for select animals.

Outreach

- In May, we held a birthday party for a lucky eight-year-old girl and several of her friends. They made no-sew blankets for the animals and socialized several foster kittens. The family has since become one of our new foster recruits!
- Our Kiddies 2 Kitties program relaunched in June on the first and third Wednesday of each month and has been well attended so far.
- o In June, staff partnered with the Palo Alto Humane Society to offer an Adoptables Art Program through the Children's Discovery Museum. A videographer produced a video tour of the Animal Care Center as part of the program.
- In May, we participated at the Santa Clara Health and Wellness Fair at the Senior Center.
- In May, we had a booth at the Campbell Boogie Music Festival complete with kittens which garnered lots of attention.
- The Companion Animal Cupboard has continued to help our community's residents who are experiencing financial hardship.

- Miscellaneous
 - We've been making a concerted effort to bring in dogs from local shelter and rescue partners. The dogs are getting adopted quickly and it's a win-win, not only for the dogs (and SVACA) but for the shelters that are overpopulated and need the help.

SHELTER TEAM

- The following are a sampling of adoption cases that highlight the good work that staff does in an effort to find lifelong homes for all of our animal guests.
 - SVACA was contacted by a business to assist with a mother cat and her three kittens in their store. Animal Control Officer (ACO) Morris responded to secure the kittens but the mother was not located so she set a humane trap. A short while later Lola was safely confined and transported to SVACA where she was reunited with her kittens. Lola and her kittens were later adopted into loving homes.

o Monae was a gorgeous cat who was found at a busy Santa Clara park and showed herself to be quite friendly and social. Project Reunite was conducted but we were unable to locate an owner for this sweet feline. Miss Monae was adopted in no time and now has her own Instagram page and adoring fans.

MEDICAL TEAM

- The following are a sampling of the good work that our medical team does day-in and out as we attempt to make sick and injured animals healthy so they can be adopted, released to a placement partner, or returned to their owner.
 - O Chibi, a senior Maltese mix, was found running loose in Campbell; he and his running mate, Nicholas, were matted and fearful. At intake it was clear that Chibi had advanced dental disease, which is a common finding in small breed dogs and senior animals. During his stray hold, Chibi was started on antibiotics in preparation for an evaluation of his oral cavity while under anesthesia. At his neuter, the majority of his teeth were found to be loose and were removed. The remaining teeth were cleaned and antibiotic therapy continued. About one week post-operatively he received a makeover and was moved into the adoption gallery and adopted that day!





From rags to riches!

o In June, SVACA staff saw two cats with similar severe leg injuries come through our doors. Maxxy, an approximately eight-month-old, black and white domestic shorthair cat, arrived with a portion of his leg bone protruding from his ankle. He had been found near Central Park in Santa Clara. He was stable, though uncomfortable, on his injured leg but because the injury had calcified in this abnormal position it was beyond surgical repair; radiographs revealed he also

had suffered a pelvic fracture. The limb was removed, and he is currently rehabbing in foster care with a previous SVACA amputee!

FIELD SERVICES TEAM

o In Santa Clara, Field Services Manager Pedrotti responded to a kitten trapped in the engine compartment of a vehicle in SVACA's parking lot. The reporting person had originally found the kitten elsewhere but when they arrived the kitten managed to escape and ran into the engine compartment. The kitten was safely removed from the vehicle, treated for a minor upper respiratory infection and moved into our Happy Meower program for a little extra TLC. Shortly after, August was adopted into a loving home.

The owner was on vacation and left her beloved dog with a sitter. Officer Gonzalez returned Gracie after ensuring there would be no further escapes.

In Campbell, ACO Gonzalez responded to a report of a kitten stuck in the engine of a vehicle. The reporting party stated that she observed a kitten under a car and when she approached the kitten jumped up and into the engine compartment. The owner of the car came out to assist but all efforts to free the kitten failed. Once darkness had fallen, and using food and a trap, the vehicle owner was able to capture the kitten. The kitten, now named Jane, was quickly adopted.
