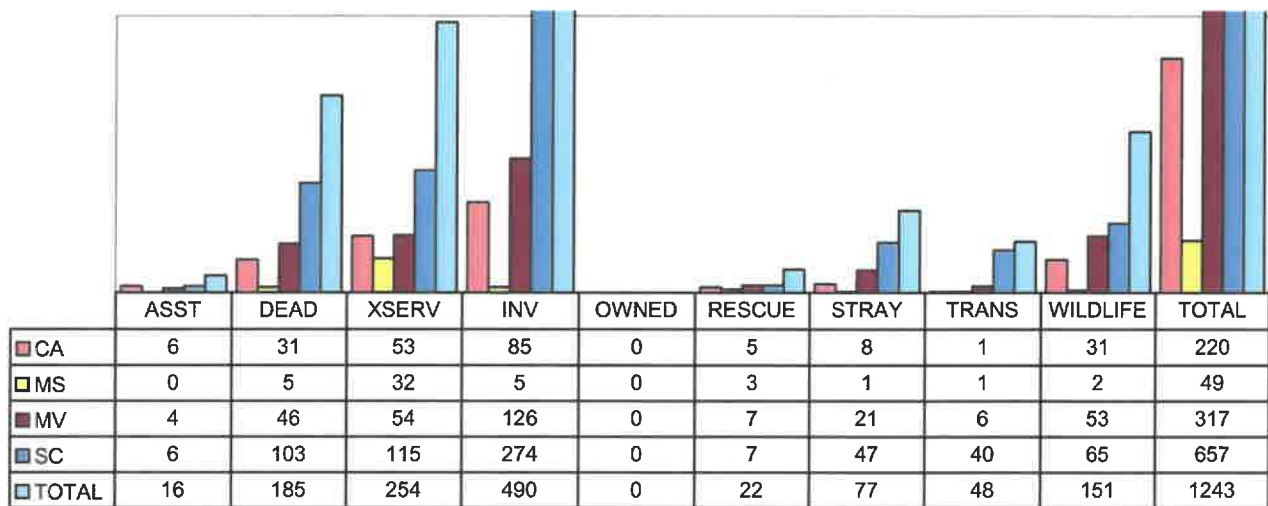
Introduction

This report provides graphs, tables and explanatory narratives covering five categories of information: field service calls, violations and citations issued, animals impounded, animals licensed, and animal outcomes. SVACA’s fiscal year is July 1 – June 30.

1. Field Service Calls

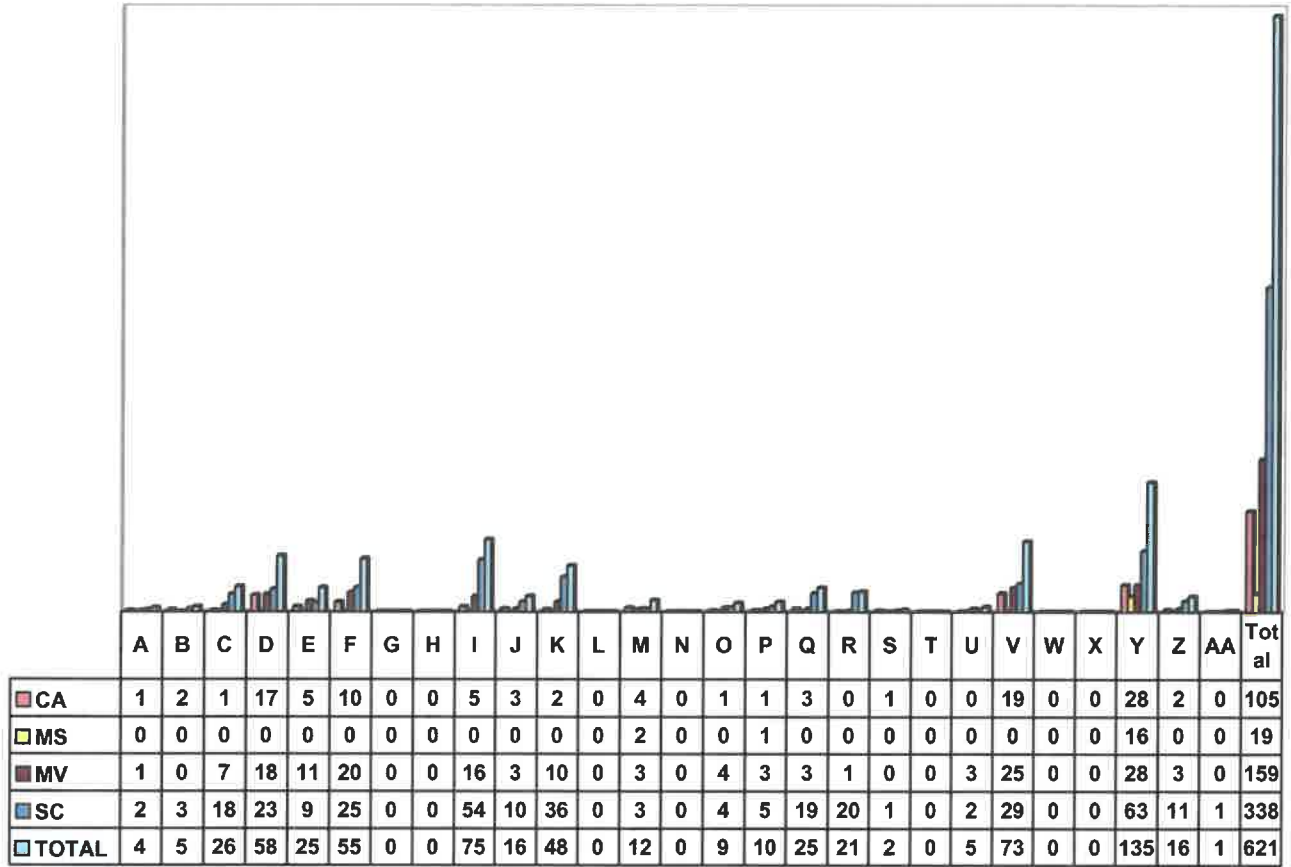

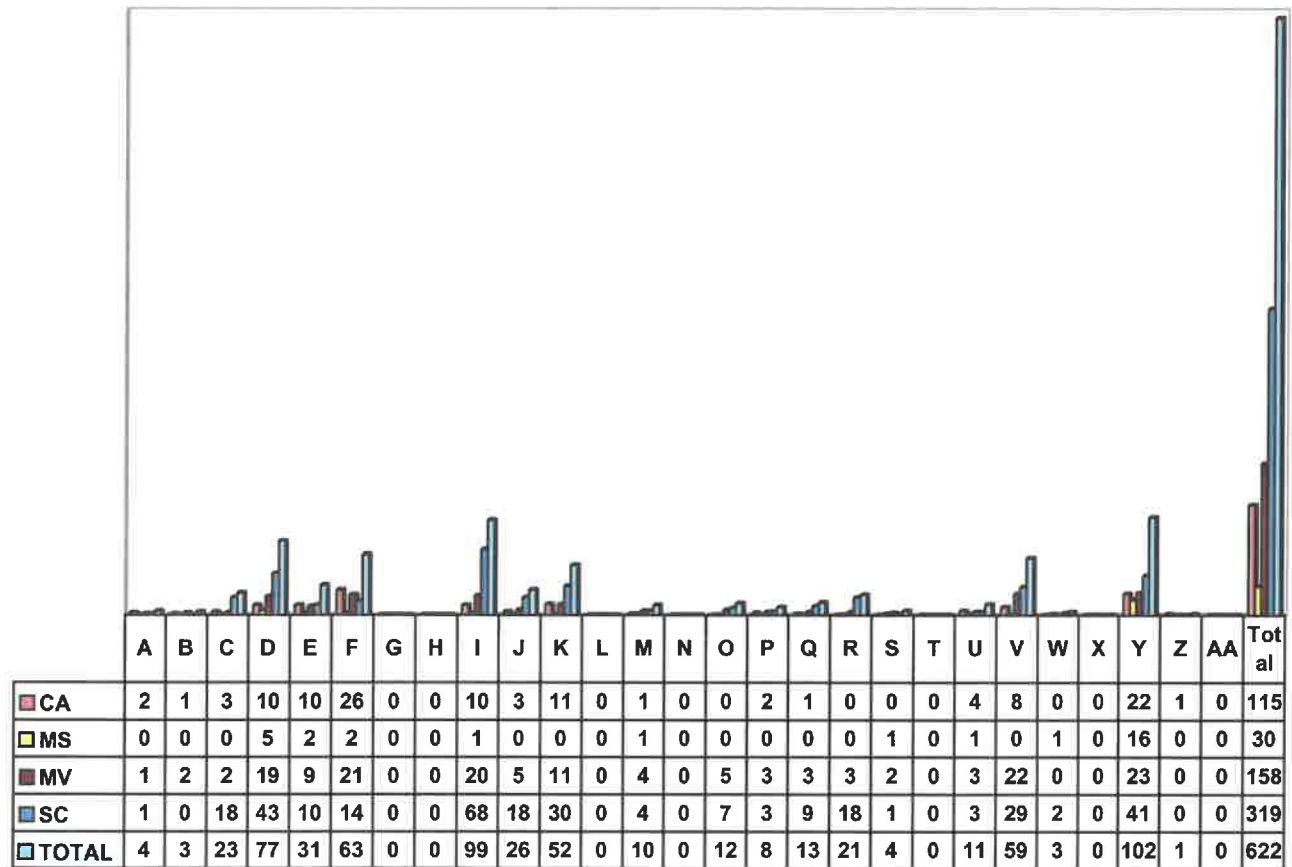
Graph 2a. - Total Service Calls by Jurisdiction, Type and Sub-Type for July 2022

Graph 2b. - Total Service Calls by Jurisdiction, Type and Sub-Type for August 2022



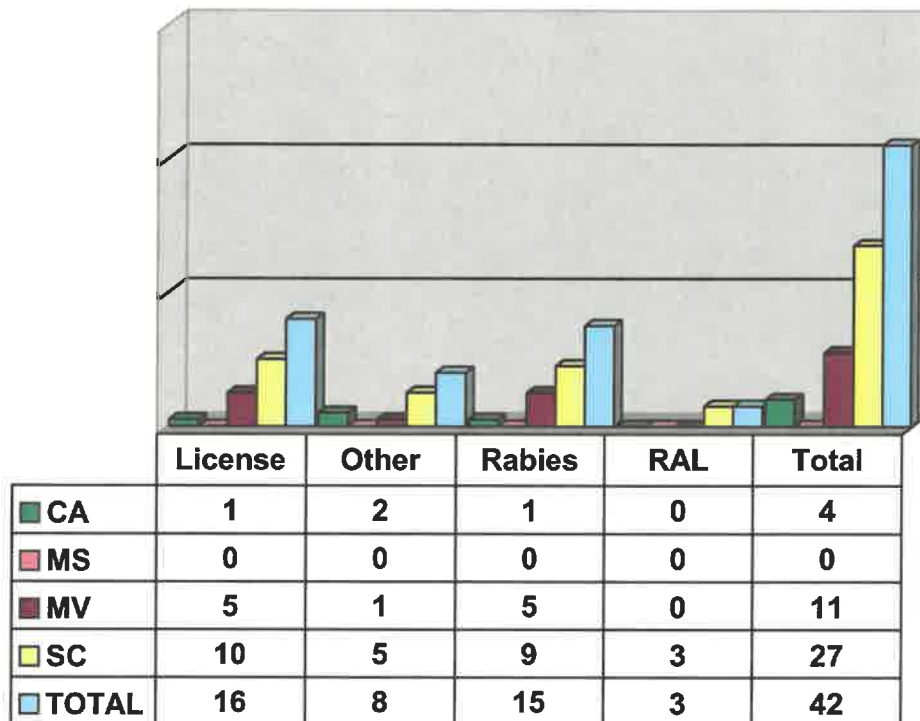

Year to Date Comparison of Violations for FY 2022-23 and FY 2021-22

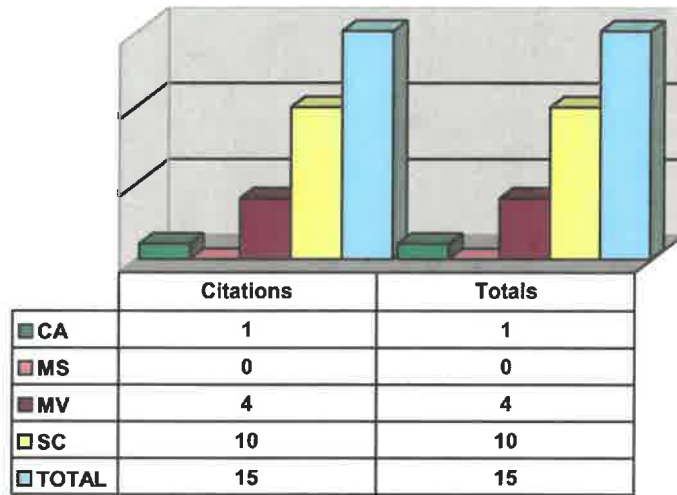

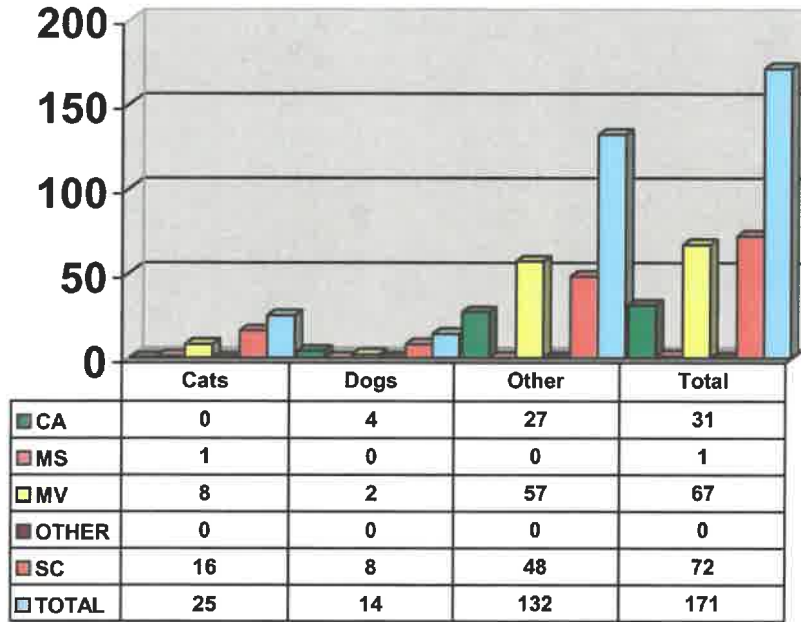

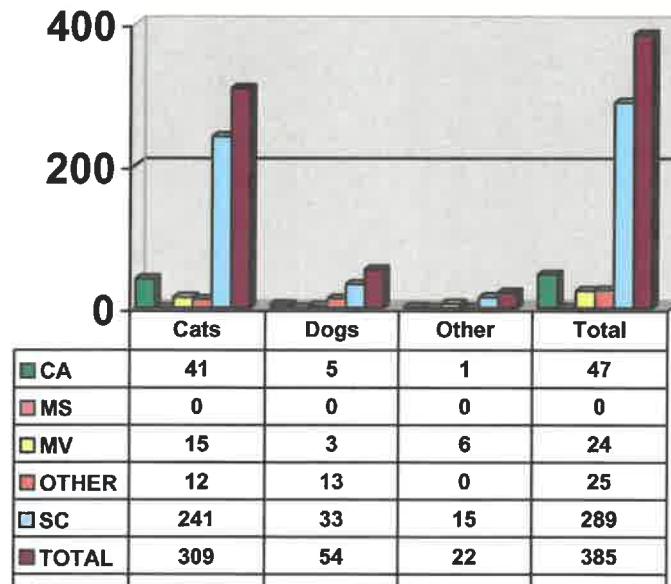
3. Animals Received at Center

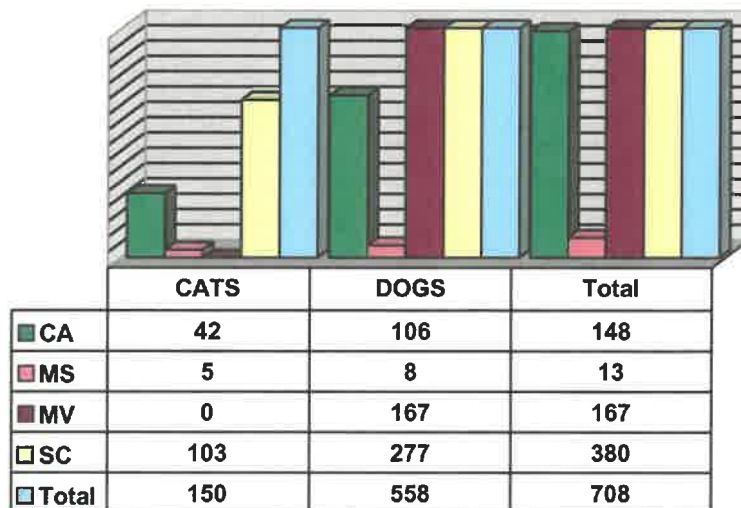

Year to Date Comparison of Licenses Sold for FY 2022-23 and FY 2021-22

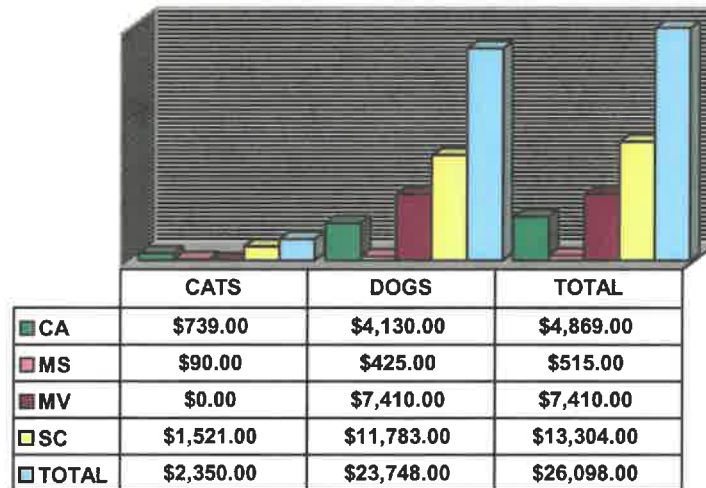

5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (www.asilomaraccords.org) which were generated by animal welfare professionals as a way for agencies to accurately report a “Live Release Rate,” or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all “healthy” and “treatable” animals as well as many “unhealthy” animals. SVACA’s Animal Care Center is “no kill” as we annually save greater than 90% of animals received.

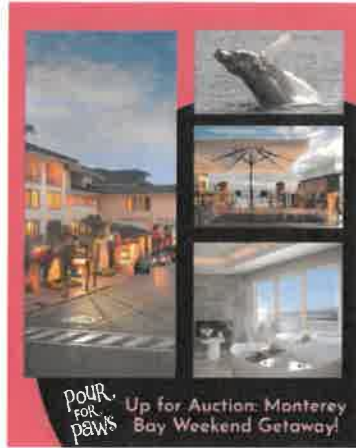

ANIMAL CARE CENTER ACCOMPLISHMENTS AND HIGHLIGHTS

- SVACA’s team continued to work through the pandemic. Unfortunately, a fifth team member fell ill in July. Due to our protocols, the infection did not take place at SVACA and there was no spread to others at the center. We continue to do our best to provide a safe workplace while balancing other needs unrelated to the pandemic. We do expect more team members to become ill as we move through the winter and the potential for closures due to a lack of healthy staff.
- Animal intakes increased when compared to last year but the team has done a tremendous job meeting the demand. All are pulling in the same direction which led to a record 114 adoptions in July followed by a whopping 82 in August. Even with the additional animals in our care, we achieved a 99% live release rate for the period. Remarkable efforts by incredible people continues to lead to outstanding results for the animals and our community during this unprecedented time in history.

OUTREACH

- Fundraising
 - The Pour for Paws event team worked hard to collect donations for auction and prize drawings. All facets of the event are on target for another successful benefit—live music, silent and live auctions, prize drawings, great food and wine selections and a dog buffet for the canine guests.

- Volunteers
 - We held a volunteer orientation in July and onboarded 43 recruits.
 - We held a dog mentoring class to train new volunteers in August.
- Marketing
 - The monthlong Clear the Shelters campaign, an annual, nationwide effort that focused on 'clearing the shelters,' was truly record-breaking for us. We adopted a total of 82 animals.

- Outreach
 - Our Kiddies 2 Kitties program is growing in popularity and continues to be well attended.
 - Staff worked with a group of Girl Scouts who were earning a Silver Award and collected items from our wishlist from the community.
 - One of our own young high school volunteers painted several portraits of our adoptable animals for an Adoptables Art exhibition.
 - We attended the Monte Sereno Annual Picnic at Vasona Park.
 - The Companion Animal Cupboard has continued to help our community's residents who are experiencing financial hardship.

 - Winnie, a Chihuahua mix, was found in Santa Clara by group of friends at Civic Center Park. Staff immediately recognized she was a senior girl, probably 14-16 years old, but very spry and happy. A mammary mass was noted at her intake evaluation and the medical team was confident that it was superficial enough to be easily removed. After her stray hold expired, Winnie was spayed and the mass was removed; her surgery was a success! After a few days rest, she was moved into the adoption gallery and found a forever home in just one day!
