
#### Introduction

This report provides graphs, tables and explanatory narratives covering five categories of information: field service calls, violations and citations issued, animals impounded, animals licensed, and animal outcomes. SVACA's fiscal year is July 1 – June 30.

#### 1. Field Service Calls



Graph 2a. - Total Service Calls by Jurisdiction, Type and Sub-Type for July 2023















#### 5. Animal Outcomes

The following tables reflect how our dogs and cats were outcomed at the center for the reporting period. The following is based on the Asilomar Accords (<a href="www.asilomaraccords.org">www.asilomaraccords.org</a>) which were generated by animal welfare professionals as a way for agencies to accurately report a "Live Release Rate," or how many animals had favorable outcomes. It also reports and categorizes why animals were euthanized. SVACA places all "healthy" and "treatable" animals as well as many "unhealthy" animals. SVACA's Animal Care Center is "no kill" as we annually save greater than 90% of animals received.

#### ANIMAL CARE CENTER ACCOMPLISHMENTS AND HIGHLIGHTS

#### **OUTREACH**

- Volunteers
  - o We initiated 40 new recruits and 42 volunteers attended our dog mentoring class.
  - We held a foster orientation and recruited several new families who have all been put to work!
  - Our Happy Meower Program helped unsocialized kittens become purr monsters, making them great candidates for quick adoption.

#### Outreach

#### Miscellaneous

o We have continued to help dogs from local shelters and placement partners. Tt's a win-win, not only for the dogs (and SVACA) but for the shelters that are overpopulated and need the help. Since the start of the California All for Animals grant cycle on September 1, 2022, we've brought in and adopted 82 dogs.

#### **SHELTER TEAM**

  - Seven-week-old Loki was received as a stray and placed into a loving foster home after no one came to look for him. Loki had a blast with his foster family and loved playing with the resident dog spending his days socializing, learning basic commands and looking cute! Once he was old enough to be altered, he returned to SVACA and was adopted on his very first day! His new family is overjoyed to have been able to open their home to Loki and they love him dearly.

O Daisy was found as a stray pup in the city of Mountain View. After Project Reunite was completed and an owner was not located, SVACA quickly placed Daisy up for adoption. Daisy's soulful brown eyes and never-ending wagging tail caught the attention of a kind adopter who recently lost his beloved dog. Their connection was instant when they met. Life is going great for Daisy these days. Her adopter reports that Daisy loves car rides and they have the best time hiking together!

#### **MEDICAL TEAM**

- The following are a sampling of the good work that our medical team does day-in and out as we attempt to make sick and injured animals healthy so they can be adopted, released to a placement partner, or returned to their owner.
  - Marianne Favro's story began in May when she arrived with her siblings. The little calico kitten was a very tiny 6 ounces while her brothers were over one pound. She was weak and had a severe upper respiratory infection; both nasal and ocular symptoms were present at intake. She was started on antibiotics and a staff member fostered her to provide the extra TLC she needed. Her right eye had an ulceration that ultimately caused so much damage to the eye that it would require removal. She was slow to grow but was finally ready for surgery, make that *surgeries*, in August when she reached two pounds. Our veterinarian removed the eye in the first surgery at the beginning of August, placing her on antibiotics post-operatively; her spay surgery took place two weeks later. She went into our adoption gallery and was adopted soon after settling in. She has a new forever home in San Francisco!

#### **FIELD SERVICES TEAM**

 In Mountain View, Animal Control Officer (ACO) Morris responded to a report of an injured hawk hiding in a bush. The hawk was safely captured and transferred to the Wildlife Center of Silicon Valley for care.

o In November 2022, ACO Morris responded to a report of possible animal abuse in Mountain View. A recording from a camera which the owner had set up to keep an eye on her dog while she was away showed the violator picking up the 4-pound dog and slamming her to the ground. The violator was issued a citation for violating California Penal Code 597, "Crimes against animals" and the case was forwarded to the district attorney's office for prosecution. The violator pled guilty to a misdemeanor and was sentenced to 25 hours of community service, 1-year probation, must attend an 8-hour animal abuse class, and attend an anger management class.

o In Santa Clara, ACO Gonzalez responded to a report of two dogs left in a car for hours at a time. She found the dogs to be in good condition, the windows down and water present. The dog owner was located and educated about the possible consequences of leaving animals in unattended vehicles and was issued a humane notice. She stated that going forward she would leave the dogs with a friend.



Educating owners about proper care is key in improving the lives of animals.
